TERMS AND CONDITIONS

- 1. Tender document instruction and specification can be viewed / downloaded from e-tender portal at https://etender.mlc.gov.pk
- 2. The tenderer shall submit 2% bid security of the estimated cost in the shape of call deposit and upload / attach its valid soft copy along with bid challan with the electronic bid before closing date & time.
- 3. The tenderer is bound to electronically submit verified and genuine documents as well as call deposit, if in case his documents are found altered / fake / bogus, the Cantonment Board is at liberty to initiate criminal proceedings by lodging FIR on the basis of forgery / fraud against the tenderer and he / his firm shall be black listed.
- 4. The tenders can only be submitted in electronic format through e-tender portal from date of publication in newspaper and portal, the deadline for submission of tender is 15 106 2021 at 1200hrs tenders would be opened on the same day at 1400hrs in the presence of contractor or their authorized representatives.
- 5. "Single stage one envelope E-tendering system will be adopted / followed" method of procurement / work / tendering will be adopted as envisaged in PPRA rules.
- 6. No manual tender shall be entertained.
- 7. Any information regarding the e-tender can be obtained from the office of the Cantonment Board Wah during office hours. Furthermore, the contractor user manual regarding bidding has been uploaded in English and Urdu language on the e-tender portal, which can be accessed and downloaded.
- The validity of Tender / Quotation rates shall be minimum upto 180 days as per PPRA / PEC Rules.
- 9. The Cantonment Board reserves the rights of demanding the analysis of the quoted rates from the concerned tenderer to check their responsibility and workability.
- 10. In case if the lowest tendered rate is less than reasonable rates the lowest tenderer shall have to deposit standing security (refundable after successful completion of the work) @15% of estimated cost in the shape of Call Deposit Receipt (CDR) within 05 days. In case of failure the

- already deposited **2%** carnest money shall be forseited and the tender shall be offered to **2nd** lowest participant as per rules.
- 11. The quantum of work may increase / decrease as per PPRA Rules and lowest tenderer shall be bound to execute the work on similar rates / terms & conditions.
- 12. Bidding documents will be issued keeping in view the relevant PEC's Category, criteria and job specialization.
- 13. Rates should be quoted on the basis of MES Schedule of Rates **2014** (amended upto date) for schedule items and market rates for non-schedule items.
- 14. Conditional / incomplete tenders / quotation wherein necessary details are missing will not be accepted.
- 15. Works will be executed as per availability of funds.
- 16. The issuance of work orders shall be subject to approval of from CFA / release of grant.
- 17. Successful tenderer will be bound to deposit mandatory dues as already resolved by the Board and shall have to execute an agreement (at their own cost) on non-judicial stamp paper of appropriate value for faithful execution of the contract.
- 18. The Cantonment Board / Executive Officer reserves the right to reject all tenders as per PPRA's Rules No. **33(1)** due to any reason thereof.

CONTRACTOR REGISTRATION

o Sing Up

Contractor must register himself through ML&C portal (https://entender.mlc.gov.pk) and click on "SignIn / SignUp" Button for sign up by entering Login ID (must be unique), NTN Number, Company Name, Password, Confirm Password and Mobile Number. An OTP (One time password) will be sent to the mobile number. Enter OTP and click SignUp Button

o Sing In / Log In

 Contractor can view tender after sign-in by entering credential (login II) and Password). Provided while sign up.

Contractor Profile

 Contractor must complete the contractor profile in order to participate in the in the bidding process, which includes Company Profile, Registration Details, Work History, Team Profile and Documents Attachments then submit it for approval.

E-BIDDING PROCESS

o Contractor can bid on tender only if;

- Logged in to the ML&C E-Tendering System
- Approved / Registered contractor with Cantonment Board Wah
- Valid PEC Category. Code and License
- o For submission of bid, contractor must provide CDR details, attach scan copy of CDR and submit.
- o After submission of the bid, contractor can view the submitted bid on the dashboard.
